I am voluntarily choosing to skateboard at this facility. As lawful consideration for permission to use this facility. I AGREE TO RELEASE FROM ANY LEGAL LIABILITY AND AGREE NOT TO SUE Kinnaird Park Community Church and the Woodshop Skate Park, its pastors, elders, deacons, officers, agents, employees, volunteers, for any and all injuries, including death, or property damage caused by or resulting from any participation in skateboarding whether or not such injury, death, or property damage was caused by alleged negligence.

I AGREE TO INDEMNIFY, DEFEND, AND HOLD HARMLESS Kinnaird Park Community Church or the Woodshop and its pastors, elders, deacons, officers, agents, employees, volunteers, for and all claimed asserted or liability established for damages or injuries to any person or property that arise out of or are in any manner directly or indirectly connected with my participation in skateboarding or presence at the skate park facility, and all expenses of investigation and defending against same, provided however, that my duty to indemnify and hold harmless shall not include any claims of liability arising from the established sole willful misconduct of Kinnaird Park Community Church, the Woodshop, its pastors, elders, deacons, officers, agents, employees, and volunteers.

I agree that this AGREEMENT AND RELEASE OF LIABILITY is intended to be as broad an inclusive as is permitted by law. Any provision found to be invalid or unenforceable by a court shall not affect the validity or enforceability of any other provision.

In further consideration of permission to use the skate park facility, I agree that Kinnaird Park Community Church and the Woodshop may use my appearance, name, and likeness in connection with my use of the facility in any publication, including news releases, without my prior consent. I further agree that I am not entitled to any compensation for such use of my appearance, name and likeness.

In connection with any injury I may sustain, or illness or other medical condition, I may experience during my participation or attendance at the skate park facility, I authorize any emergency first aid, medication, medical treatment or surgery deemed necessary by attending medical personnel if I am not able to act on my own behalf. I further authorize the attending medical personnel to execute on my behalf any permission forms, consents, or other appropriate documents relating to medical attention and to act on my behalf if I or my parents or guardian are not able or immediately available to do so.
